

ELIGIBILITY CRITERIA AND INSTRUCTIONS FOR COMPLETING THIS FORM *(Please read)*

- ❖ **NOTE: The incentive amount for this program is \$500.**
- ❖ To qualify for the incentive the home must meet the following requirements:
 - New home must be built on Eau Claire Energy Cooperative's lines.
 - New home must be certified as meeting or exceeding the Focus on Energy New Homes Program efficiency requirements.
 - ✓ Certification must be done by a Focus on Energy Building Performance Consultant. A list of local consultants can be found on the back of this form.
 - **If an electric water heater is installed in the home it must be connected to one of ECEC's load management programs and it must have a Uniform Energy Factor of .90 or greater for water heaters up to 99 gallons or .85 or greater for water heaters 100 gallons or greater. The water heater must also meet the eligibility criteria of the load management program it is to be connected to.**
- ❖ Incentives are in place through December 31, 2019, **or until funds are depleted**. Funds are limited and program is subject to change or cancellation without notice, so members are encouraged to submit incentive application as soon as possible.
- ❖ **Submit the documentation listed below no later than 3 months after certification, or by December 31, 2019, whichever comes first. Homes certified in 2019, but not requesting an incentive until 2020 may qualify for a 2020 incentive, provided there is an incentive available at that time.**
 - ✓ This Incentive form **(Incentive forms that are not fully completed will not be processed)**
 - ✓ Documentation that shows the home was certified as meeting or exceeding the Focus on Energy New Homes Program efficiency requirements (Focus on Energy New Homes Program Certification Workbook)
