A. Availability

Available under established rules and regulations for street and outdoor lighting.

B. Type of Service

Single-phase, 60 hertz, 120-volt service. Dusk to dawn automatically controlled outdoor light fixture.

C. Rate

250-Watt High Pressure Sodium (HPS) .....	\$13.85 per month
400-Watt High Pressure Sodium (HPS) .....	\$18.00 per month
175-Watt Mercury Vapor* – <b>Closed Rate</b> .....	\$8.15 per month

100-Watt High Pressure Sodium (HPS) .....	\$12.60 per month
150-Watt High Pressure Sodium (HPS) .....	\$15.95 per month
175-Watt Mercury Vapor * – <b>Closed Rate</b> .....	\$12.60 per month

\* The High-Pressure Sodium (HPS) will eventually replace all Mercury Vapor units. No new Mercury Vapor units will be installed. Failed Mercury Vapor units will be replaced with High Pressure Sodium Units.

E. Terms of Payment

Payment is due when the bill is received. In no circumstances will the cumulative time before notice of disconnection be less than 20 days after the date of issuance of the bill and an account may be deemed delinquent for the purpose of disconnection after such period has elapsed. A late payment charge of 1% per month will be added to utility bills not paid and credited prior to the succeeding monthly billing.
